If you use commercial or private health insurance to pay for your Janssen medication



Eligible patients pay \$5 per dose*

*\$20,000 maximum program benefit per calendar year. Not valid for patients using Medicare, Medicaid, or other government-funded healthcare programs to pay for their medications.
