If you use commercial or private health insurance to pay for your Janssen medication



Eligible patients pay \$5 per dose

\$26,000 maximum program benefit per calendar year. There is no income requirement. Terms expire at the end of each calendar year and may change. See program requirements at <code>JanssenCarePath.com</code>.

To determine eligibility, enroll in the Savings Program, submit Savings Program requests, and manage program benefits, visit MyJanssenCarePath.com.
