



## RelayHealth eVoucherRx™ for XARELTO®

Dear Pharmacist,

Because you access RelayHealth's eVoucherRx™ service, we are writing to inform you that Janssen Pharmaceuticals, Inc., is sponsoring an eVoucher program for XARELTO®, starting July 29, 2021.

Please read the important information about the eVoucherRx™ program for XARELTO® below.

The eVoucherRx™ program for XARELTO® is for eligible patients using commercial or private insurance. Eligible commercial patients pay \$10 for each 90-day prescription, subject to program benefit limits. There is no limit to this benefit for the first 90 days, and then a \$200 limit for each 30-day supply thereafter. There is a \$3,400 maximum program benefit per calendar year.

This program is only available to people using commercial or private health insurance for their Janssen medication. This includes plans from the Health Insurance Marketplace. This program is not for people who use any state or federal government-funded healthcare program. Examples of these programs are Medicare, Medicaid, TRICARE, Department of Defense, and Veterans Administration. Patients may not seek payment for the value received from this program from any health plan, patient assistance foundation, flexible spending account, or healthcare savings account.

Patients must meet the program requirements every time they use the card. Program terms will expire at the end of each calendar year. The program may change or end without notice, including in specific states. To use this program, patients must follow any health plan requirements, including telling their health plan how much co-payment support they get from this program. This program offer may not be used with any other coupon, discount, prescription savings card, free trial, or other offer. Offer good only in Pennsylvania and Florida. Void where prohibited, taxed, or limited by law.

If you suspect a government program may be a payer on an eVoucher transaction for XARELTO® or if a patient requests not to have an eVoucher apply to his or her prescription, please contact RelayHealth immediately at 800-388-2316, to request reversal of the application of the eVoucher to the patient's prescription.

The eVoucherRx™ program is not insurance. The patient is not required to purchase any other product or service to use the eVoucher on a prescription for XARELTO®. It is Janssen's expectation that for each prescription for XARELTO® to which an eVoucher has been applied, your pharmacy will inform the patient of the amount of the patient benefit (patient co-pay assistance) received and the fact that the patient benefit was paid by Janssen Pharmaceuticals, Inc. The patient benefit amount must be passed through to the patient in its entirety; no portion of the patient benefit amount may be retained by the pharmacy and the pharmacy may not charge the patient any premium or other amount for handling the eVoucher transaction.
