## Savings Program

### Am I eligible?

You may be eligible for the Janssen CarePath Savings Program if you currently use private or commercial health insurance to cover a portion of your medication costs for ZYTIGA<sup>®</sup>.

### Other requirements

- This offer may not be combined with any other coupon, discount, prescription savings card, free trial, or other offer.
- **This program is only available to individuals using private or commercial health insurance to cover a portion of their medication costs, including plans available through state and federal healthcare exchanges. This program is not available to individuals who use any state or federal government-subsidized healthcare program to cover a portion of medication costs, such as Medicare, Medicaid, TRICARE, Department of Defense, or Veterans Administration. Patients confirm that they will not seek reimbursement from any of these programs or from pharmaceutical patient assistance foundations and accounts such as a Flexible Spending Account (FSA), a Health Savings Account (HSA), or a Health Reimbursement Account (HRA).**
